## Welcome new neighbors

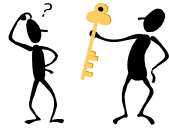

## Issues and Solutions



### Maintenance Committee at work

The Maintenance Committee, formerly made up of only one volunteer, has been revitalized this year with a team of volunteers. Some of the first of the initiatives of this committee are:

- Review alternative options for trash removal.
- Update the community on the status of termite extermination, and get copies of the activity reports. (*see page 4*)
- Start early this year for the bidding of 2009 Snow Removal & Landscaping services.
- Develop a follow-up plan for compliance of the Walk-Around inspections/violations.

The committee is developing ways to facilitate communications to home owners regarding the scheduling and status of short and long term projects.

## Did You Know



### Spring Walk-Around Inspections

Traditionally “Walk-Arounds” at Farmington Chase are completed twice a year. This is an informal inspection where the Property Manager, Superintendent, and volunteers from the Board of Directors check the exterior condition of each home in Clusters 1-7 to ensure that the home is in good repair and compliant in its upkeep. The 2008 Spring Walk Around will be scheduled next month. After it is completed you will be notified if you need to make repairs to your unit. If you would like to get prepared, here are some areas that are commonly found in need of repair:

- Side door to garage in need of paint, repair and/or replacement. **1**
- Wood trim on garage door(s) in need of paint.
- Replace siding trim on garage corners.
- Missing gutter downspouts.
- Repair and/or replacement of iron gates and the wood trim on gates.
- Repair and/or replacement of privacy fences. **2**

**1** Acceptable repair of side garage door allows for a kick plate to cover bottom of door vs. replacing the door where it will improve the condition and appearance of the door.

**2** Acceptable repairs of iron fencing and gates include the removal of the iron fencing and gates (changes should be submitted to the ACC and approved by the BOD prior to doing work.)

If you need paint, please contact Imagineers with a Service Request. Our superintendent will get you a quart of the right color to match your siding color.

Keep in mind that one of the points in the *Home Owner's Manual* in the “Homes” section states:

“You should keep the exterior of your home in a neat and orderly fashion.” *Point # 3, Page 16.*

If you violate these rules, the normal action of the Board of Directors will be as follows:

First Offense                      A letter explaining the problem is sent to you.

Second Offense                      \$25.00 fine is levied.

Third Offense                      \$25.00 fine levied. Right to use all recreational facilities suspended for 30 days.

## Zero Tolerance – Illegal Dumping

The dumpsters are for regular household trash only, including the recycling of glass, cans, newspapers and cardboard.

The Association has a “zero-tolerance” policy for the illegal dumping of inappropriate trash in and around the dumpsters – or for that matter, anywhere on the property of Farmington Chase.

Anyone found responsible for illegal dumping will be subject to a fine, as well as being charged the cost incurred to remove trash from the premises.

If you witness illegal dumping, please contact Bill Nardi, John Machowski, or any Board member. Identify a license plate, identify the offender by name or unit number, or take a photo from your cell phone of the offence while it is taking place!

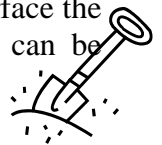
If you have questions about making changes to the outside of your home, please feel free to contact the Architectural Committee. They welcome your questions and will guide you through the association policies on this subject.

## “Call Before You Dig” Reminder

Before digging anywhere at Farmington Chase be sure to **call 1-800-922-4455**. Underground wires are close to the surface at Farmington Chase. This is a free service to help identify a potential problem. If you accidentally damage a utility line you can be injured or killed. Even if the wires were placed too close to the surface the utility company will bill you for what can be costly repairs.

## Termite Extermination Update

The Maintenance Committee's recent review of the termite extermination services at Farmington Chase explained how the program worked and the status of termite activity in our community.

Beginning in 2001, concurrent with the installation of siding in the community, Farmington Chase began receiving services for termite extermination. Bait traps are located in the ground of the front and back yards of every home in Clusters 1-7. These traps are monitored for termite activity every other month between April and October. The Sentricon system of bait is used. This "species specific" bait affects only termites. The latest site report showed that all bait stations are **INACTIVE**.

Termites will always be an issue in an area like our forest setting. Termites eat only dead wood, and eat from the surface up. Although termites are inevitably in the wooded areas, the monitoring services we receive confirm that termites are not eating at the wood structure of our homes. The next site visit will take place some time in April/May 2008.

A solution has now been put in place for the absence of by-monthly reports on the status of termite activity. The Activity Reports are now being sent directly to Farmington Chase.
