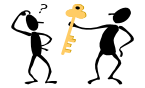


Welcome

Issues and Solutions



New Policy for cleaning of fireplace flues

As a matter of safety the subject of cleaning fireplace flues was recently discussed at the August Board of Directors meeting. Because eight (8) years have passed since the last community-wide requirement to have fireplace flues cleaned, it is certainly time to address this issue again.

Farmington Fire Marshal, Rob Warner recommended that a community development such as Farmington Chase should mandate yearly professional inspections of fireplace flues, with cleaning mandated if recommended.

Farmington Chase Association has adopted a policy of **every other year requirement to inspect fireplace flues and clean if recommended.**

Inspections and cleaning, if necessary, will need to be performed by December 1, 2008. Of the three proposals that were received, the best rates were proposed by Marcel's of New England. The negotiated rate is \$55.00 for the inspection and a total of \$75.00 for the inspection and cleaning.

Marcel's of New England can be reached at 860-658-5709 to schedule an appointment. If you choose another company, or your chimney was inspected during 2008, **verification must be sent to Imagineers no later than December 1, 2008.**

Units with gas fireplaces are exempt from this requirement, however **proof of installation of a gas fireplace must be sent to Imagineers no later than December 1, 2008.**

Farmington Chase Association - 2009 Budget

The Farmington Chase proposed 2009 Budget will be presented to the Association owners at a special meeting on Tuesday, October 7th. All owners are encouraged to attend the meeting at the Club House at 7:00 pm.

Landscaping / Snow Removal Services – Bids were recently solicited for landscaping services and snow removal services. Three companies responded. The Board of Directors unanimously voted to employ Imagineers. The decision was made to continue with Imagineers services because of their favorable proposal price for services, and as a result of an overwhelming positive response from the community for the job they did removing snow last season and their landscaping services this year.

Guidelines for Architectural Changes – Residents and owners are reminded that changes to the exterior of your home are outlined in the Farmington Chase Home Owners Manual (available on the Farmington Chase Website) on pages 19-22; “Modifying Your Home, Guidelines for Exterior Changes”. These guidelines were revised and put in print in 2001.

The Architectural Committee welcomes your questions and will guide you through the association policies about making changes to the outside of your home. Standard requests are approved by the committee; whereas unprecedented requests are brought to the next Board of Directors’ meeting for review and approval.

Dryer & Bathroom Vent duct cleaning reminder

Farmington Chase policy requires that dryer vents/ducts must be cleaned this year no later than November 1st. If a company other than Lint-B-Gone cleaned your dryer vent within the last six months, a letter of confirmation of work performed by a professional company must be submitted to Imagineers by November 1, 2008.

Fireplace Guidelines

Remember - the fireplaces at Farmington Chase were not built to provide primary heat to your home, rather, the fireplace was intended for ambiance.

In October 2000, a fire caused major damage to two homes in Farmington Chase. At that time the Farmington Fire Marshall noted that modifications such as a wood stove insert or coal/pellet stove insert was not advisable with Farmington Chase fireplaces. Additionally, at that time **“the Board initiated a moratorium on any modifications to fireplaces in the Chase”** (Homeowner Memo Re: Fireplaces dated January 25, 2001)

Here are some “Fireplace Do’s and Don’ts” from Majestic (*the manufacturer of FC fire places*):

- **DO** clean ashes out of the firebox after each fire, leaving just enough to insulate the cold hearth so your next fire will start faster.
- **DO** keep fire to ideal 3-log size (lengths ranging from 20” to 30”). Replace top and front logs as they burn up.
- **DO NOT** close damper until fire is completely out.
- **DO NOT** use synthetic logs (Duralogs) along with regular wood. This will cause excessive heat build-up.
- **DO NOT** use flammable liquids to light your fire.

6. Follow the rules.
7. Serve on a committee.
8. Serve on the board or, at a minimum, attend board meetings.

10. Help organize a community event—a food drive, holiday gift drive, or social event.
11. Vote in community-wide referendums.
12. Volunteer to serve your community.
13. Consider how your particular knowledge, skills, and experience can help the community.
14. Remember that you are a member of the community association. What is good for the association is good for you.
